

**“Walmart Gift Card Enter to Win Sweepstakes” (“Promotion”)**

**OFFICIAL RULES & REGULATIONS**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A purchase will not improve an individual’s chances of winning. The Promotion is void where prohibited by law.**

**ELIGIBILITY:**
